

## CASHBACK PROMOTION

### TERMS & CONDITIONS

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS (“TERMS”) CAREFULLY BEFORE PARTICIPATING IN THE CASHBACK PROMOTION (“PROMOTION”). PARTICIPATION CONSTITUTES YOUR ACCEPTANCE OF THESE TERMS. THESE TERMS SHOULD BE READ IN CONJUNCTION WITH THE TERMS & CONDITIONS ON INVESTMENT SERVICES AND OUR PRIVACY POLICY.

#### 1. PROMOTION OVERVIEW

The Promotion is organized by AXIORY GLOBAL LTD (hereinafter referred to as “AXIORY”) and will run from **08<sup>th</sup> July 2026 (00:00 GMT+9) until 31<sup>st</sup> July 2026 (23:59 GMT+9)** (the “Promotion Period”). AXIORY reserves the right to shorten, extend, or otherwise amend the Promotion Period at its sole discretion, with notice provided via the Client Zone or AXIORY website, where reasonably practicable. The Promotion gives eligible clients the opportunity to receive a cashback reward of JPY 10,000 on completion of the qualifying conditions, subject to these Terms.

#### 2. ELIGIBILITY CRITERIA

- 2.1 The Promotion is open to new and existing clients whose Default Partner Code is set to one of AXIORY’s selected, approved Partners, and who:
  - are aged 18 years or over;
  - have a live AXIORY trading account;
  - have not made their first deposit into a live AXIORY trading account before the commencement of the Promotion Period; and
  - have agreed to these Terms
- 2.2 Participation in AXIORY’s New Deposit Bonus and First Deposit Bonus promotions does not affect eligibility for this Promotion. However, clients who made their first live account deposit before the Promotion Period are not eligible to participate.
- 2.3 Clients may opt out from receiving the reward under the Promotion by notifying AXIORY at any time during the Promotion Period.
- 2.4 AXIORY reserves the right to verify eligibility at any time and to refuse or withdraw participation where the criteria above are not met.

#### 3. PROMOTION RULES

- 3.1 To qualify for the cashback reward, you must complete all four of the following conditions. You may complete them in order, at any point during the Promotion Period:
  - Verify your account: Your live trading account must reach at least Light Stage verification (Full Stage also qualifies);

- Make a deposit: Deposit any amount into a live trading account. Deposits to your Wallet or Alpha account also count toward this condition;
  - Trade 5 lots: Trade a cumulative total of at least 5 standard lots on FX, metals, or index instruments, across all your live trading accounts. Alpha account is excluded from this calculation. Progress is refreshed approximately once per hour on the campaign badge;
  - Follow AXIORY on X: Follow the official AXIORY X (formerly Twitter) account and submit your X handle via the Promotion badge in your Client Zone. The X account submitted must be genuine and belong to you as the claiming client.
- 3.2 Once all four conditions in 3.2 are complete, select 'Claim Reward' on the campaign badge in your Client Zone. Then, choose the live trading account or Wallet you would prefer the reward credited to. Alpha accounts cannot be selected to receive the reward. Your claim, including your submitted X handle, will then be sent for verification. Submitting a claim does not guarantee payment of the reward. All claims are subject to AXIORY's review and approval.
- 3.3 Each eligible client may submit one claim per Promotion. Duplicate claims will not be honored.
- 3.4 Once your claim is verified and approved, JPY 10,000 will be credited to your selected account as real, withdrawable balance. It carries no trading or withdrawal restrictions once credited.
- 3.5 The reward will be reflected in your transaction history as a Recent Action notification in your Client Zone.
- 3.6 The campaign badge will be removed from your Client Zone once your reward has been credited.
- 3.7 Reward verification is a manual process. Please allow a reasonable amount of time from the date of your claim for it to be reviewed.
- 3.8 The cashback reward has no cash alternative and may not be transferred, assigned or exchanged with another person. Nothing in this section restricts the client's ability to transfer funds between their own eligible AXIORY accounts in accordance with AXIORY's standard procedures.
- 3.9 You acknowledge that any indication or suspicion of any form of abuse, fraud, manipulation, in AXIORY's reasonable discretion, may lead to such account's disqualification from participation in the Promotion.
- 3.10 AXIORY will not be liable for any adverse effects where an account has open positions or floating profit/loss which results in the Promotion being removed for any reason.

### 3. GENERAL TERMS

- 4.1 AXIORY reserves the right to decline registration of any participant in the Promotion and/or disqualify any participant from the Promotion who violates or abuses these Terms or AXIORY's Terms of Business, and where necessary:
- (a) withhold, cancel and/or subtract the reward from your account(s);
  - (b) terminate your agreement with AXIORY and your access to AXIORY's services;
  - (c) block your account(s) due to abusive behavior, including but not limited to:

- (i) when you, acting by yourself or with others, open trading position(s) which have the purpose or effect of extracting the credit provided and/or profits generated by the Promotion, without exposure to economic risk, including without limitation, loss of the Promotion or your capital (or capital of others);
  - (ii) where you, acting by yourself or with others, hedge your positions, including without limitation, holding open position(s) in one direction, including by way of illustration only, single or correlated currencies, at given periods, internally (using other accounts held with AXIORY) or externally (using other trading accounts held with other brokers).
- 4.2 AXIORY reserves the right to cancel or amend the Promotion and these Terms without prior notice. Any changes to the Promotion will be notified to participants as soon as possible. Under no circumstances shall AXIORY be liable for any consequences of any alteration, amendment, suspension, cancellation or termination of the Promotion.
- 4.3 By participation in the Promotion, each participant declares and consents to the processing of their personal data collected and used by AXIORY to process them through automated and/or non-automated means. The personal data of the participants will be retained and used in accordance with AXIORY's Privacy Policy.
- 4.4 AXIORY cannot accept any responsibility for any damage, loss, injury or disappointment suffered by any participant entering the Promotion or as a result of accepting the Promotion.
- 4.5 AXIORY is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers, or providers, computer equipment or software, failure of any email or entry to be received on account of technical problems or traffic congestion on the internet, telephone lines or at any website, or any combination thereof, including any injury or damage to participants or any other person's computer or mobile telephone related to or resulting from participation in the Promotion.
- 4.6 The present Terms will be governed by the laws of Belize and any disputes will be subject to the exclusive jurisdiction of Belize.
- 4.7 Notwithstanding the translated language of these Terms, the English wording shall be binding in the event of discrepancy between the two languages.
