TERMS & CONDITIONS

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS ("TERMS") CAREFULLY BEFORE PARTICIPATING IN THE \$410 REWARD PROMOTION ("PROMOTION"). PARTICIPATION CONSTITUTES YOUR ACCEPTANCE OF THESE TERMS. THESE TERMS SHOULD BE READ IN CONJUNCTION WITH THE TERMS & CONDITIONS ON INVESTMENT SERVICES AND OUR PRIVACY POLICY.

1. PROMOTION OVERVIEW

The Promotion is organised by AXIORY GLOBAL LTD and TRADIT LTD (together hereinafter referred to as "AXIORY") and will run from **05 September 2022 (00:01 UTC) until 30 November 2022 (23:59 UTC)**, giving you the opportunity to gain 100% credit into your trading account when making a deposit (multiple deposits can be made; the combined total of all credit granted cannot exceed USD 2,000) ("Credit"). Upon fulfilling certain conditions in terms of traded volume, Credit can be converted into your balance (up to USD 410) and therefore become withdrawable ("Funds"), subject to these Terms.

2. ELIGIBILITY CRITERIA

The Promotion is open to all new an existing clients aged 18 years or over who:

- Have registered a live AXIORY trading account by providing the necessary identification documentation;
- Are eligible to trade as per AXIORY's onboarding Client Agreements; and
- Have agreed to these Terms.

3. PROMOTION RULES

- 3.1 The Promotion will run until **30 November 2022 (23:59 UTC).** Any remaining Credit received can be used for trading after **30 November 2022 (23:59 UTC)** but cannot be converted. On **31 January 2023** all unconverted Credit will be removed from your AXIORY trading account.
- 3.2 Any profits generated exclusively with the Credit are non withdrawable.
- 3.3 Upon trading a certain number of (closed) lots, traded with the tiers illustrated on the table below (not applicable to Stock CFDs, Stocks and ETFs), Credit becomes withdrawable (converts into Funds added into your balance):

Total Lots Traded	Funds (USD)
10 lots	50
25 lots	60
50 lots	100
100 lots	200

- The maximum amount of Funds that can be rewarded is \$410. Lots will be calculated from the first deposit made during the term of the Promotion.
- 3.4 The Promotion may be combined with any other credit or cashback received on trading volume which AXIORY may offer from time to time. Cumulative credit granted shall not exceed USD 5,000.
- 3.5 The Promotion is available on a per-client basis (not on a per-account basis), regardless of the number of accounts held with AXIORY.
- 3.6 You will be able to transfer funds from another account held with AXIORY into the account that has been awarded with the Promotion (incoming internal transfer). However, if you transfer funds from the account awarded with the Promotion into another account held with AXIORY (outgoing internal transfer), the Promotion will be proportionally moved and alternatively removed as per the example provided in paragraph 3.9 below.
- 3.7 If you place a withdrawal before the end of the Promotion, the Promotion will be removed proportionally from your trading account.
- 3.8 Any profit earned via trading with the Promotion can be kept and withdrawn in accordance with AXIORY's withdrawal of funds procedure. Withdrawal fees apply.
- 3.9 In the event the equity [the balance (closed positions) in the trading account plus the floating profit and loss from open positions] on the account reaches negative value ("equity without credit") the Promotion shall be automatically removed and the account will be reset back to zero. Please see examples below:

Example 1:

Equity = 10,000 USD

Credit = 5,000 USD

Equity without credit = 10,000 - 5,000 = 5,000 USD

In this example, the remaining equity on the trading account is 5,000 USD, and so the Promotion is not removed.

Example 2:

Equity = 4,999 USD

Credit = 5,000 USD

Equity without credit = 4,999 - 5,000 = -1 USD

In this example, the equity reached the negative value of -1 USD, and so the Promotion is automatically removed.

- 3.10You acknowledge that any indication or suspicion of any form of abuse, fraud, manipulation, in AXIORY's reasonable discretion, may lead to such account's disqualification from participation in the Promotion.
- 3.11AXIORY reserves the right to decline registration of any participant in the Promotion and/or disqualify any participant from the Promotion who violates or abuses these Terms or AXIORY's Terms of Business, and where necessary:
 - (a) withhold, cancel and/or subtract credit from your account(s);
 - (b) terminate your agreement with AXIORY and your access to AXIORY's services;
 - (c) block your account(s) due to abusive behaviour, including but not limited to:
 - (i) when you, acting by yourself or with others, open trading position(s) which have the purpose or effect of extracting the credit provided and/or profits generated by

- the Promotion, without exposure to economic risk, including without limitation, loss of the Promotion or your capital (or capital of others);
- (ii) where you, acting by yourself or with others, hedge your positions, including without limitation, holding open position(s) in one direction, including by way of illustration only, single or correlated currencies, at given periods, internally (using other accounts held with AXIORY) or externally (using other trading accounts held with other brokers).
- 3.12AXIORY will not be liable for any adverse effects where an account has open positions or floating profit/loss which results in the Promotion being removed for any reason.

4. GENERAL TERMS

- 4.1 AXIORY reserves the right to cancel or amend the Promotion and these Terms without prior notice. Any changes to the Promotion will be notified to participants as soon as possible. Under no circumstances shall AXIORY be liable for any consequences of any alteration, amendment, suspension, cancelation or termination of the Promotion.
- 4.2 By participation in the Promotion, each participant declares and consents to the processing of his/her personal data collected and used by AXIORY to process them through automated and/or non-automated means. The personal data of the participants will be retained and used in accordance with AXIORY's Privacy Policy.
- 4.3 AXIORY cannot accept any responsibility for any damage, loss, injury or disappointment suffered by any participant entering the Promotion or as a result of accepting the Promotion.
- 4.4 AXIORY is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers, or providers, computer equipment or software, failure of any email or entry to be received on account of technical problems or traffic congestion on the internet, telephone lines or at any website, or any combination thereof, including any injury or damage to participants or any other person's computer or mobile telephone related to or resulting from participation in the Promotion.
- 4.5 AXIORY will not accept any responsibility for the damage, loss, injury or disappointment suffered by any participant of the Promotion.
- 4.6 The present Terms will be governed by the laws of Belize and any disputes will be subject to the exclusive jurisdiction of Belize.
- 4.7 Notwithstanding the translated language of these Terms, the English wording shall be binding in the event of discrepancy between the two languages.
